CLERY CORNER

What is a Campus Security Authority?

A Campus Security Authority (CSA) is an individual, who by virtue of their college responsibilities under the Clery Act, is designated to receive and report criminal incidents to NWACC DPS or the Compliance Office. CSAs include Campus Police and Security Officers, individuals or departments who have been identified for reporting criminal incidents, individuals or departments who have significant responsibility for student and campus activities, or other individuals who have a responsibility for campus security that are not campus police. CSA reports are used to compile statistics for Clery Act reporting and to help determine if there is a serious or continuing threat to the safety of the campus community that would require a timely warning.
