- always wash hands before eating

- wipe down your workspace (desk, keyboard, mouse, etc.) often
- stay home from work if you're feeling ill (i.e. fever, sore throat, coughing, difficulty breathing, vomiting, headaches, ear pain) even if you think the symptoms are minor, and make sure you notify your supervisor

### Personal Security Tips

### Familiarize Yourself with NWACC Police and Public Safety Dept.

· Understand the ways to contact DPS (Phone, LiveSafe app, email)

 $\cdot$  Get to know your police and security personnel in person

 $\cdot$  Get to Know the layout of campus buildings (Emergency exits, AED locations, severe weather shelter areas, etc.) where you attend classes

### Take Extra Precautions Walking Around Campus at Night

· Use the "Buddy System" (you and a friend to and from class, parking close, walking out together)

- $\cdot$  Always keep Family and Friends notified of whereabouts
- · Call Public Safety for a safety escort if needed-any time day or night (free service provided by DPS)
- · Be aware of your surroundings and limit distractions when walking (do not stare at your phone screen)

· While walking around campus or to and from classes have your LiveSafe app open to utilize safe Walk or to use the emergency button if needed.

### ALWAYS Lock up

 $\cdot$  DO NOT leave your vehicles unsecured in parking lots. Always take the extra time to ensure valuables are not visible inside your car and that windows are up and doors locked

Maintain Vigilance and Awareness

 $\cdot$  Time of day, weather, who is walking nearby, and general situational awareness
